**\*Overall Progress Narrative**

Fourteen Acquisitions and five Rehabilitation contracts were executed during the April - June 2010 reporting period. Seven of the acquired properties were closed on during this quarter. Twelve Environmental Reviews were conducted. One property was gifted to a local non profit. Rehabilitation was started on two properties while others are in various stages of finalizing contracts or initiating rehab.
