AGREEMENT

I, _____ the undersigned owner of the premises known as _____ hereby apply for a permit for the construction or renewal of a sidewalk opening /vault pursuant to the Amended Sections of 4-5-91 through 4-5-96 of the City of Birmingham, 1980 and hereby agree to construct same in accordance with all conditions and requirements which are applicable to the construction hereby requested.

I hereby state that I am the owner of the aforesaid premises and in consideration of the granting of this permit, I hereby agree as follows:

1. That the existing vaults and/or sidewalk openings shall include the accurate gross measurements of the vault and/or shafts, together with accurate dimensions and locations of all sidewalk openings and a description of the materials and techniques used are to be provided by me prior to issuance of the renewal.
2. That the existing vault and sidewalk opening applications as well as the annual renewal shall contain a certificate from a structural engineer registered in the State of Alabama certifying the load capacity of the existing structure and certifying that the structure is satisfactory for its current use.
3. Any permit for a vault or sidewalk opening shall be renewed on an annual basis. Each annual renewal application shall be accompanied by proof of insurance and required Engineer's Certificate: sidewalk openings applications shall also show proof of bonding as required. The renewal date shall be on the annual anniversary of the issuance of the permit.

CERTIFICATION

I hereby certify that I have read this application and that all information contained herein is true.
